- Rates apply for non-hazardous cargo only, unless specified in our quotation.
- Rates are subject to VAT. VAT is not Included unless otherwise specified
- All rates are calculated at today's tariffs and rate/s of exchange, which are subject to alteration without prior notice.
- Any advice and / or information given to you on the dates of loading, discharging, arrival, transit time etc are subject to change without any notice.
- Any shipments effected after the validity date of our offer will be charged according to the prevailing general tariff at the date of the shipment.
- Any storage/demurrage charges incurred due to the delay in moving the cargo to/from destination/origin will be for the account of cargo owner at the place charges have occurred.
- BAF is subject to fluctuation as per shipping line's instructions.
- BUC, EBS or BAF (Bunker Surcharge) is subject to monthly fluctuations in each trade concerned as per shipping line's instructions
